1 OPENING SPEECH BY THE CHAIRMAN

- 1.1 The Chairman welcomed the Members to the 30th Annual General Meeting of ASCM (AGM). The Chairman announced that the requisite quorum being present, the meeting was called to order.
- 1.2 The Chairman introduced the Members of the Management Committee and the invitees present.
- 1.3 Before commencing the formal proceedings of the AGM, the Chairman made a presentation on the major activities undertaken by ASCM in 2016. The presentation is as attached per the Appendix 1 to this minutes.
- 1.4 The Chairman then shared the engagement effort made by ASCM with the authorities and industry bodies. With regards to the engagement with the Ministry of Finance, the Chairman informed the members that ASCM had presented and discussed pertinent industry issues with the Minister of Finance II on one-to-one basis. The Chairman added that ASCM had also discussed industry issues with the SC at the SC Industry Dialogue 2016 as well as at other ad-hoc meetings with the SC. On engagement with Bursa, the Chairman shared with the members that ASCM presented industry issues at the Securities Market Operations Committee meetings, Market Participants Committee meeting, Trading Lab session as well as at various industry consultations. The Chairman further shared with the

members that ASCM were also represented in the SC's CPE Advisory Group, SIDC's BTF and BDREF Board and Committees, SC's Industry Competency Framework as well as in the Working Group of the Financial Services Professional Board.

- 1.5 On engagement with the SC, the President further informed the members that ASCM had also managed for SC to conclude that the implementation of Third Party Receipts is to be based on individual broker's internal control criteria and procedures which they feel are practical and principle-based.
- The Chairman then invited the Treasurer to present ASCM Financial Highlights for 2016. The Treasurer shared with the meeting that ASCM had disbursed CMDF incentive on new BFE system amounted to RM1.02 million to the members. On the Education and Training, the Treasurer said that ASCM had managed to obtain funding from Bursa to organize ASCM's Securities Industry Conference. ASCM had also secured funding from SIDC to conduct 4 BDFEF funded courses. On the Comprehensive Crime and Professional Indemnity (CCPI) Insurance Policy, ASCM had managed to negotiate a referral commission from Marsh Insurance Brokers for administrating the CCPI.

- 2.2.1 The Treasurer led the members through the statutory financial statements for the financial year ended 30 June 2016 and the auditors' report. The Chairman then invited questions on the accounts and reports from the floor.

- 2.2.2 TML enquired on the bad written off amounted to RM43,771.00. The Treasurer replied that the expenses was due amount incurred in liquidating exercise of Just Asec Sdn Bhd (JASB) paid to the liquidator, Ferrier Hodgson. The amount includes secretarial fee, taxation fee and auditing fee paid by ASCM on behalf of JASB. The liquidation exercise is expected to be completed by 2017.
- 2.2.3 The financial statements and audit report were then proposed to be adopted by TCS and seconded by DAM. The members unanimously agreed to adopt the financial statements and auditors' report.

2.3 AGENDA 3: TO APPOINT THE AUDITORS AND TO AUTHORIZE THE MANAGEMENT COMMITTEE TO FIX THEIR REMUNERATION

- 2.3.1 The resolution to appoint Siew Boon Yeong & Associates as auditors until the conclusion of the next AGM and to authorize the ASCM Management Committee to set the fees paid to the auditors was proposed by TMC and seconded by LSH.
- 2.3.2 The members unanimously agreed to appoint Siew Boon Yeong & Associates as auditors until the next AGM and to authorize the ASCM Management Committee to determine their fees.

2.4.1 The Chairman advised the meeting that 4 Member Companies will be retiring at this AGM but eligible for re-election. The 4 Member Companies are Aminvestment Bank, BIMB Securities, Mercury Securities and PM Securities. All the Member Companies eligible for re-election accepted the nominations except Aminvestment Bank had declined nomination. 3 OTHER MATTERS

- 3.1 OGT proposed seek CMDF financial assistance in the implementation of cyber security by the brokers. The President supported OGT's proposal and suggested ASCM to seek feedback from the members on the type of financial assistance needed. The Chairman added that as for the rising cost of doing business, ASCM had raised the issue to SC and they are currently conducting an industry cost study.
- 3.2 The Chairman shared with the meeting than Bursa has recently sought proposals to liberalize the Rules of Bursa Malaysia Securities in order to promote market growth and facilitate ease of doing business. The Chairman then invited members to respond to ASCM's memo on this matter for ASCM's deliberation and submission to Bursa.
