**EXTENSION OF TIME FOR SUBMISSION OF CDS TRANSACTION FORMS TO BURSA MALAYSIA DEPOSITORY SDN BHD DURING THE CONDITIONAL MOVEMENT CONTROL ORDER**

As part of Bursa Malaysia Depository Sdn Bhd's ("Bursa Depository") effort to encourage Work From Home ("WFH") during the period of Conditional Movement Control Order ("CMCO"), Bursa Depository will extend the time for the submission of physical CDS transaction forms to Bursa Depository to all Authorised Depository Agents (ADAs).

The extension of time provided for the submission of physical CDS transaction forms to Bursa Depository are as follow:
